All vendors will be submitted to the Maryland Comptroller and you will individually receive from the Maryland Comptroller applications for tax identification numbers.

DEADLINE: All completed vendor applications must be returned with vendor fees by **Monday, April 27, 2015**. Spaces will be assigned on a first-come basis based on vendor's compliance with the standards and philosophy of the Augustoberfest Charitable Foundation.
